


## 3 Activation

You are required to activate the control panel first before you can use the control panel. Activation via SADP, and activation via web are supported. The default values of the terminal are as follows:

### Activate Device via Web Browser

- 3. Confirm the password, and activate the device.
- Make sure the IP segment of the device and the computer is the same.


